Craig Wyrick, called the meeting to order at 5:15 P.M.

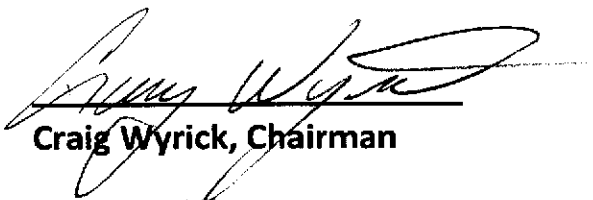
No one was registered for comments.

New Business—Action Items:

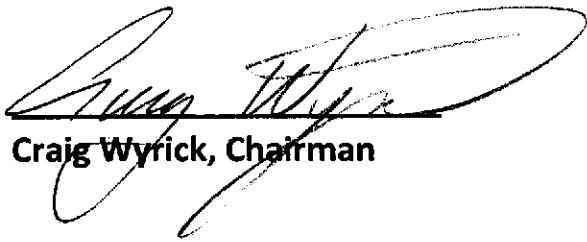

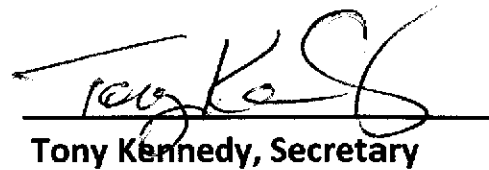
New Business — Non-Action Items:
